The Company has a land at Mira Road, Mumbai. All the interest expenses are thus transferred to Work in Progress. The company has reported loss of Rs. 33829/- as compared to loss of Rs. 11402/- from the previous year.

### Business Review/State of the Company's Affairs

The Company is mainly engaged in construction activities. It is currently engaged in the construction on its land holdings at Mira Road, Mumbai.

### Share Capital

During the financial year 2021-22 the Company has not issued any additional Equity shares. The Company has also not offered to issue any Equity Shares as Sweat Equity Shares or through the Employee Stock Option Plans. The paid up Issued Capital of the Company as at the end of the year was Rs. 24,78,000/- divided into 2,47,800 Equity Shares of Rs. 10/- each. None of the Equity Shares have been issued with differential voting rights.

During the Financial Year 2021-22 the Company does not propose to carry any amount to its General Reserves and proposes to keep the accumulated profits under the head of "Profit & Loss Account" itself.

### Dividend

For the financial year ended 31<sup>st</sup> March, 2022 profit is not adequate therefore, the management is not desirous of recommending or issuing any Dividend.

Your Company did not have any funds lying unpaid or unclaimed for a period of seven years. Therefore there were no funds which were required to be transferred to Investor Education and Protection Fund (IEPF). Further the Company has also not issued any dividends during the financial year 2021-22.

**Significant Accounting Policies**
